

**AMENDMENT No. 3 TO GENERAL PROCUREMENT NOTICE No. 1**

**Government of the Hashemite Kingdom of Jordan  
Millennium Challenge Account-Jordan**

The Government of the Hashemite Kingdom of Jordan has received grant funding of US\$ (275.8) Million from the Millennium Challenge Corporation (MCC) of the United States Government to enable the Government of Hashemite Kingdom of Jordan to implement this program and achieve the objectives of the MCC Grant (Compact), and it intends to apply parts of the proceeds of the funds to payments for Contracts for Goods, Works and Services.

The procurement program for the next six months will include the following:

<b>1.3</b>	Water Smart Homes (WSH) Activity: P3 Water Network Construction
<b>1.4</b>	Water Smart Homes (WSH) Activity: P4 Water Network Construction

Contracts for Works and Services financed under the program will be implemented according to the principles, rules and procedures set out in the MCC Program Procurement Guidelines which can be found at the MCA-Jordan's website<sup>1</sup>.

The Procurement is open to all bidders from eligible source countries as defined in the MCC Program Procurement Guidelines.
